PROJECT ECHO: KNOWLEDGE SHARING NETWORKS AND COLLABORATIVE CARE MANAGEMENT ASSISTING HEALTH CARE PROVIDERS

Tara Jackson, Ph.D.

Tara Jackson, Ph.D. joined Oklahoma State University Center for Health Sciences (OSUCHS) in 2017 as the Director of Project ECHO. OSUCHS Project ECHO is an innovative program dedicated to increasing access to specialty care in rural and medically under served areas in Oklahoma. As Director, she is responsible for the development, administration, and advancement of Project ECHO. Prior to joining Project ECHO, Ms. Jackson served as the LARC Program Director with the University of Oklahoma Department of Family & Preventive Medicine where she was responsible for the administration, implementation and oversight of this statewide LARC Project. The LARC Project was an initiative to decrease the high rates of teen

and unplanned pregnancy in Oklahoma through increased access to contraceptive methods including LARC. Ms. Jackson also served as the Director of the Take Control Initiative where she was responsible for development, implementation, and evaluation of a privately funded LARC Initiative which resulted in a 33% reduction in teen birth rate and 40% reduction in abortion rate. She received her B.S in Health Education and Promotion with an emphasis in Public Health, Master's Degree in Health Care Administration and Policy and has completed her Doctor of Public Health at the University of Oklahoma Health Sciences Center. Her graduate training focused on using innovative thinking to address complex issues of public health policy and using advanced analytical and managerial tools to lead organizational and societal change. Ms. Jackson's career includes extensive experience in women's reproductive health and health policy including Director of Take Control Initiative, Administrator for Oklahoma State University Department of Obstetrics and Gynecology Residency, and partnering with the Catholic Diocese to establish and develop their maternal health center. She has been invited to participate on national women's reproductive health expert panels, and has partnered extensively with national women's reproductive health leaders such the University of California, San Francisco where she collaborated to design and implement a community Capacity Building LARC Champion training, pilot tested social media campaign for the National Campaign to Prevent Teen and Unplanned Pregnancy, as well as the Brookings Institute, American College of Obstetricians Gynecologist and others. She was a member of Fetal Infant Mortality Review team and has worked with many state and local organizations to provide education and increase women's access to health care.
