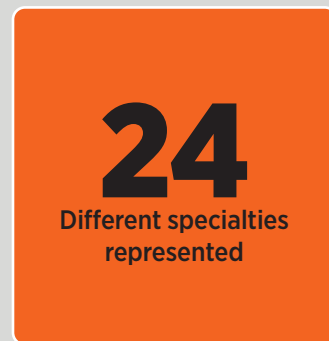
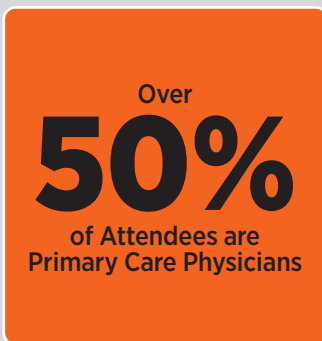

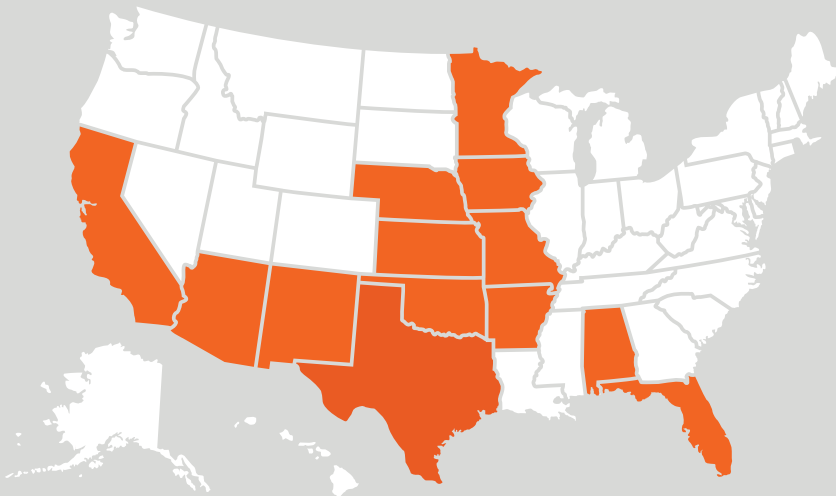
# JOIN US!

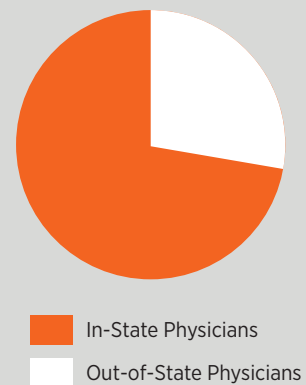
## 2019 PRIMARY CARE UPDATE STATISTICS

## Virtual Exhibit Hall
