- Community providers learn from specialists
- Community providers learn from each other
- Specialists learn from community providers



SESSION DETAILS

- > Brief Didactic (20 minutes or less includes time for Q&A)
- > Case presentation
 - Problem narrative
 - Questions/Clarifications about narrative
 - Recommendations and strategies from group
 - Summary of recommendations
- > Announcements
 - Updates from spoke sites and hub team
 - Reminders about our Box.com resources
 - Next session information





HOW TO PARTICIPATE IN AN ECHO

5 WAYS TO GET THE MOST OUT OF A SESSION

1. Contribute to meaningful discussions.
2. Actively engage. Don't forget to turn your webcam on.
3. Be open and learn from others.
4. Share your knowledge. Your contributions are invaluable.
5. Maintain confidentiality. Follow FERPA and HIPPA protocols.

ZOOM CONNECTION TIPS

- Click on the Zoom connection link that is provided in your weekly email invitation. This should take you into a Zoom meeting room.
- Complete short ZOOM registration form (aka "Sign-In" sheet)
- Select "Join Audio by Computer." You can then test the volume of your speaker and mic to ensure everything is working by clicking "Test Computer Audio."
- Once you have successfully tested the audio, you should be able to see a toolbar at the bottom of the Zoom screen by hovering over it.
- The buttons needed as an ECHO participant include:

	NAME OF BUTTON	FUNCTIONALITY/PURPOSE
	MUTE	Mute and unmute once you enter the meeting. Standard protocol is the ENTER the meeting MUTED and remain as such until acknowledged by panel. *6 to mute/unmute on phone.
	STOP VIDEO	Turn video on/off once you enter the meeting.
	SHARE SCREEN	Shares your desktop. NOTE: Your desktop will automatically be displayed. Close all open items before sharing.
	CHAT	Chat function. Two types of chats: TO EVERYONE (default) PERSONAL/PRIVATE
Leave Meeting	END/LEAVE MEETING
