

Osteopathic Recognition Eligibility Criteria for D.O. Graduates

I. Successful Graduation from a Commission on Osteopathic College Accreditation (COCA)-accredited college of osteopathic medicine (COM).

- **Applicant will be a designated osteopathic resident upon matriculation into the program.**

Osteopathic Recognition Eligibility Criteria for Non-D.O. Applicants (graduates of a medical school in the United States)

I. 20 Business Days Prior to the Match Rank Opening Date, the Applicant Must Have Ready for Submission:

- 60 online hours of OSU-COM's years one and two to include; *OMM I, II, III, and IV. A Teaching Guide for Osteopathic Manipulative Medicine* or lectures may be used to direct the lab portion. Certificate of completion will be provided. OMM education from outside institutions will not be accepted.
- Contact the Program Coordinator for access to OMM I-IV videos
- Successfully pass the OSU Osteopathic Written Exam with a minimum passing score of >50%. Programs will create an individual learning plan if the score is <50% and the applicant matriculates into the program.

60 item question composed of:

- 40% on Osteopathic Concept and Philosophy
 - 40% on Osteopathic diagnosis
 - 20% on Osteopathic treatment methods

- **Applicant will be a designated osteopathic resident upon matriculation into the program as long as the above requirements are met.**

II. During Residency and Fellowship*

- Complete 60 hours of OPP Continuing Medical Education, approved by the OSU-CHS/OMECO, achieved through any of the following: CME courses, didactics, elective rotations, etc. focusing on clinical application of Osteopathic Principles and Practice.
- Successfully pass an OMM basic skills competency practical examination prior to PGY-2.
- Satisfactorily progress through the Osteopathic Recognition Milestones during residency.

* Exceptions during one or two-year fellowships must be requested through the GME Office and requested at the time of application to the program.

Osteopathic Recognition Eligibility Criteria for Non-D.O. Applicants (graduates from a medical school outside of the United States)

I. Must be eligible to attend residency training in the United States per local applicable laws and facility policies.

II. Must hold a currently valid certificate from the Educational Commission for Foreign Medical Graduates (ECFMG) prior to appointment; or, hold a full and unrestricted license to practice medicine in the United States licensing jurisdiction in which the ACGME-accredited program is located.

III. Must complete USMLE Step 1 and USMLE Step 2 prior to matriculation.

IV. 20 Business Days Prior to the Match Rank Opening Date, the Applicant Must Have Ready for Submission:

- 60 online hours of OSU-COM's years one and two to include; *OMM I, II, III, and IV. A Teaching Guide for Osteopathic Manipulative Medicine* or lectures may be used to direct the lab portion. Certificate of completion will be provided. OMM education from outside institutions will not be accepted.

- Successfully pass the OSU Osteopathic Written Exam with a minimum passing score of >50%. Programs will create an individual learning plan if the score is <50% and the applicant matriculates into the program.
